<u>Duration</u>: commitment period of eleven (11) full months plus the *prorata* of the month during which the Package was activated. At the end of the commitment period, the Package is automatically renewed for successive periods of one (1) month.

<u>Termination</u>: In case of termination prior to the expiry of the commitment period, You will be required to pay an early termination fee calculated as follows: the monthly fee equivalent to Our cheapest package existing at the time of Your subscription applied to the number of remaining months between the end of the 30-day notice period and the end of Your minimum commitment period.
